Ordinance 14-03

The final reading of Budget Ordinance 14-03 was read in its entirety by Clerk Miller.

AN ORDINANCE OF THE TOWN OF ST. LEO, PASCO COUNTY, FLORIDA ADOPTING THE FINAL LEVYING OF ADVALOREM TAXES AND MILLAGE RATE FOR THE TOWN OF ST. LEO, FLORIDA, FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2015; PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

Clerk Miller stated that the FY 2014-2015 operating millage rate is .75 mills, which is lower than the rolled-back rate of 2.76 mills by -72.85%.
